Significant parts of the Heytex Group sold to new investor

Bramsche, September 24, 2024 - Private equity investor Bencis Capital Partners is selling the core business of the Heytex Group with three production sites (two in Germany and one in China) and all central functions, including sales, research and development and administration, to Freudenberg Performance Materials (FPM). FPM is active in the market for coated technical textiles, as Heytex is, under the Mehler Technologies brand. In 2023, the relevant part of the Heytex Group generated sales of around EUR 100 million with approximately 400 employees. The transaction is subject to the approval of the antitrust authorities.

Bramsche 9 月 24 日消息 — 私募股权投资公司 Bencis Capital Partners 将把海德思集团的核心业务，包括三家工厂（两个在德国、一个在中国）以及包括销售、研发和管理在内的所有核心职能出售给科德宝高性能材料集团(FPM)。和海德思一样，FPM 以米勒品牌活跃于涂层技术纺织品市场。2023 年，海德思集团相关部门的销售额约为 1 亿欧元，拥有约 400 名员工。这笔交易需要得到反垄断机构的批准。

The merger under one roof will enable the new group to strengthen its technology platform and market presence, expand research and development capacities and benefit from each other.
